## Professor of Practice and Faculty Director for the Center for Business, Government, and Society Tuck School of Business, Dartmouth College

Joined Tuck after more than a decade "up campus" at Dartmouth. Will teach courses on subjects ranging from health economics to the future of capitalism. Also the faculty director for Real Talk, a part of the Tuck Dialogues Project designed to promote viewpoint diversity sponsoring events on "hot" topics and timely issues.

#### Lecturer in Public Policy, Harris School of Public Policy, University of Chicago (spring 2024)

Will spend a visiting term at the University of Chicago teaching a course on analyzing and communicating public policy.

## Founder and Chair Emeritus, Unite America (Since 2014)

Created a nonpartisan organization with an annual operating budget of \$4 million dedicated to fostering a more representative and functional government. Unite America is currently focused on promoting state-level process reforms, such as independent redistricting, ranked-choice voting, and vote by mail. The organization was a major supporter of the Alaska referendum to adopt a single nonpartisan primary with ranked choice voting in the general election. The *Atlantic* described the Alaska referendum as the "biggest win yet" for the political reform movement and credited Unite America as a group that "pushed it over the line." Unite America spearheaded a similar referendum win in Nevada in 2022.

#### Naked Government: An Inside Look at How the Sausage Gets Made, Work in Progress

This will be the fourth "naked book" published by W.W. Norton. The book will examine the nature of governance: why we need government; how it has been done historically; what makes democracy "the worst form of government except for all those other forms that have been tried from time to time"; and how we can make democracy and government work better.

# Getting US in the Game: How the Best of Sports Can Lead Us to the Best of America, Work in Progress

What does it mean to be American? What is the shared vision for our nation? And how can we expect our political process to function if there is no agreement on these foundational questions? In the spirit of *The Centrist Manifesto*, this book will shape our public dialogue by offering a 21<sup>st</sup> century American narrative and proposing a handful of policies consistent with that vision, from national service to a carbon tax. Collaborating with Matthew Slaughter, dean of the Tuck School of Business, and John Hamill, a trial and civil rights attorney.

# Write for Your Life: A Guide to Clear and Purposeful Writing (and Presentations), W.W. Norton & Company, 2022

A guide to clearer, more effective writing based on years of experience as a journalist, columnist, speech writer, political candidate, novelist, screenwriter, and author of popular nonfiction books.

### We Came, We Saw, We Left: A Family Gap Year, W.W. Norton & Company, January 2021

A nonfiction family memoir of the Wheelan Family trip around the world: nine months, six continents, three teenagers. The paperback edition was selected as the nonfiction book of the month by Barnes & Noble for May of 2022.

#### The Rationing (fiction), W.W. Norton & Company, May 2019

A debut novel based on a pandemic striking the U.S. and the subsequent political machinations. *Booklist* described it as "an eminently credible tale of a worst-case scenario that one hopes never comes to pass." (It did.)

## Naked Money: What It Is and Why It Matters, W.W. Norton & Company, 2016

An accessible tour of money, banking, and central banking. Includes chapters on Japan's deflation, the 2008 financial crisis, the fate of the euro, and other money-related contemporary issues.

## The Centrist Manifesto, W.W. Norton & Company, 2013

The book that launched Unite America warned of rising partisanship and proposed policies for empowering America's political middle. Reviewed in *The Economist* and other prominent publications.

### Naked Statistics: Stripping the Dread from the Data, W.W. Norton & Company, 2013

A layperson's guide to statistics, in the same vein as *Naked Economics*. Three weeks after publication, the book reached the *New York Times* bestseller list for hardback nonfiction. *The San Francisco Chronicle* called it a "brilliant, funny new book."

### Introduction to Public Policy, W.W. Norton & Company, 2010

The first and most comprehensive economics-based introductory public policy text. The book defines a core set of skills and concepts that make up the essential building blocks of public policy and is the first public policy text written by someone who has been trained in the field (as opposed to a single academic discipline) and has extensive practical experience in public policy, both in the U.S. and abroad.

## Naked Economics: Undressing the Dismal Science, W.W. Norton & Company, 2002

Updated with a third edition in 2019, the book is an accessible and entertaining introduction to economics for lay readers and is now being published in more than 14 languages. The *Chicago Tribune* described *Naked Economics* as "clear, concise, informative and (gasp) witty." The book has enjoyed widespread course adoption at the high school and college level, including at the University of Chicago. In 2023, the *Wall Street Journal* picked *Naked Economics* as the best business book ever, just ahead of Michael Lewis's *Moneyball*.
